III. AGENDA DISCUSSION ITEMS:

a) Extension of Moratorium on Car Service Station

Mayor Pro Tem clarified at the start of the discussion that the topic is actually related to fuel service stations. Current moratorium expires today. Staff working on regulations to address the issues. Planning Commission scheduled a Special Called Meeting for June 22nd at 6pm to review draft text amendments. Draft code will be available for review June 11th. Mr. Summerbell will conduct presentation at next week's work session, before going to Planning Commission, at the request of council.

Motion 1 – Made by Council Member Tammy Grimes that council approve 60-day extension on gas station moratorium that was in effect since February 7, 2021. Seconded by Mayor Pro Tem George Turner.

b) Creation of a Community Council

Staff recommended three-month trial period to approve overall transparency and communications by creating a Community Council. Staff also recommending Community Council Meeting, facilitated by City Managers Office, be held at City

Motion 2 – Made by Council Member Rob Turner to approve the recommendation of creation of Community Meeting as outlined by Mr. Summerbell in his report. Seconded by Council Member Jazzmin Cobble.

Motion passed unanimously.

c) Proposed Amendments to the Zoning Ordinance

Staff on schedule to draft text amendments ready for review by June 11th. A Special Called Meeting of the Planning Commission is scheduled for June 22nd. This item was submitted as information only. No action necessary.

d) Revocation of Check Signing Privileges
Follow up to ordinance change made at last Special Called Meeting. Provision
written by City Attorney, which was necessary to protect interest of the city.
