RESOLUTION NO. 2023-04-02

A RESOLUTION BY THE MAYOR AND COUNCIL OF THE CITY OF STONECREST, GEORGIA TO APPOINT MEMBERS TO THE STONECREST DEVELOPMENT AUTHORITY; TO PROVIDE FOR REPEAL OF CONFLICTING RESOLUTIONS; TO PROVIDE FOR AN EFFECTIVE DATE; AND TO PROVIDE FOR OTHER LAWFUL PUPOSES.

WHEREAS, Chapter 62 of Title 36 of the Official Code of Georgia Annotated, known as the "Development Authorities Law " creates in each municipality in the State of Georgia a public body corporate and politic to be known as the " development authority " of the municipality; and

WHEREAS, the Development Authorities Law is passed pursuant to authority granted from the General Assembly in ARTICLE IX, SECTION VI, PARAGRAPH III of the Constitution of this state; and

WHEREAS, the City Council of the City of Stonecrest (the "City") finding the necessity to establish one such authority to develop and promote trade, commerce, industry and employment opportunities for the public good and the general welfare created the Stonecrest Development Authority ("SDA") and appointed its initial directors in March 2018; and

WHEREAS, pursuant to O.C.G.A § 36-62-4 the "development authority" of such municipal corporation, shall consist of a board of not less than seven and not more than nine

directors to be appointed by resolution of the governing body of the municipal corporation; and

WHEREAS, pursuant to O.C.G.A. § 36-62-4 at the expiration of the current terms of office of the first four members of the board of directors, the City shall elect successors to such members to serve for initial terms of two years and shall elect successors to the remaining members of the board for initial terms of four years; and

WHEREAS, thereafter, the terms of all directors shall be for four years

WHEREAS, in accordance with O.C.G.A. § 36-62-4 the Mayor and Council (“City Council”) wish to appoint directors to serve on the SDA.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Stonecrest, Georgia that the Directors of the Stonecrest Development Authority shall be appointed as follows:


BE IT FURTHER RESOLVED, all resolutions, ordinances, and parts thereof in conflict herewith are hereby expressly repealed.

BE IT FINALLY RESOLVED, the effective date of this Resolution shall be the date of adoption, unless otherwise specified herein.


