PURPOSE: The auditing firm of Bambo Sonaike, CPA, LLC concluded their audit of the City of Stonecrest Procurement card usage from January 2017 to November 2020. As a part of the audit, there was a review of all procurement card transactions, review of monthly reconciliations, review of general ledger posting, review of internal controls and interviews with the Mayor, Council, and city staff. A part of the overall scope of work was to provide a presentation of the findings to the Mayor and Council.

HISTORY: The City of Stonecrest had a procurement card program in place since January 2017. The City issued a Request for Proposal on November 30, 2020 to get an outside firm to assist with determining if the procurement card activity adhered to established policies and procedures of the City and to provide an assessment of internal controls that are in place to reduce the risk of violation of the City's purchasing policy.

FACTS AND ISSUES: The Mayor and Council was presented with the original report from audit firm on April 16, 2021. After that time there were more receipts located and the supplemental report was updated to reflect those findings. The findings of the audit show

deficiencies in adherence to established policies and procedures and in internal control systems that will be addressed by Finance. The audit firm has provided recommendations for the City of Stonecrest. A detailed corrective action plan to incorporate the recommendations of the audit will be presented to Mayor and Council at a later date.



INDEPENDENT ACCOUNTANT'S REPORT ON APPLYING AGREED-UPON PROCEDURES

To the Honorable Mayor and Members of the City Council City of Stonecrest, Georgia

Scope

We have performed the procedures enumerated below, which were agreed to by the City of Stonecrest, Georgia "City", to review the procurement card use from January 2017 to November 2020. This engagement only covers procurement cards in use by the City from the period January 2017 to November 2020.

Methodology

This agreed-upon procedures engagement was conducted in accordance with attestation standards established by the American Institute of Certified Public Accountants. The sufficiency of these procedures is solely the responsibility of those parties specified in this report. Consequently, we make no representation regarding the sufficiency of the procedures described below either for the purpose for which this report has been requested or for any other purpose.

Background

On September 14, 2020 the City's fiscal year 2019 financial statements audit performed by another external audit firm was presented to the Mayor and Members of the City Council. The management letter for the aforementioned audit report included an observation and recommendation from the external auditor regarding the safekeeping and control of the City's purchase cards.

On November 30, 2020 the City issued a request for proposal No. 2020-010 to review the procurement card use from January 2017 to November 2020.

Engagement Objectives

The objective of this engagement is to review the procurement card use by the City from January 2017 to November 2020.

Engagement Scope and Procedures

This engagement scope only covers procurement cards in use by the City from the period January 2017 to November 2020.

Our engagement was conducted in accordance with attestation standards established by the American Institute of Certified Public Accountants. We applied these standards to review the City's procurement card usage. Our procedures include but were not limited to the following:


- 1. Determine if the procurement card activities adhered to the established policies and procedures of the City
- 2. Determine if appropriate internal controls are in place to reduce the risk of violation of the City's purchasing program
- 3. Review of all procurement card transactions
- 4. Review of monthly reconciliations

- 5. Review of General Ledger posting
- 6. Review of Internal controls
- 7. Interviews with Mayor, Members of the City Council and personnel

Overall engagement results

The City's procurement card activities had significant instances of non-compliance with established policies and procedures and the internal control system surrounding the purchasing program was not appropriate to reduce the risk of violation of the purchasing program. The overall results of our engagement are as follows:

1. **Overall environment** - since the inception of the purchasing program until the end of first quarter 2019 the program had an average non-compliance ratio of 5.0% and subsequent periods had an average non-compliance ratio of 71.4%. The graph below shows the quarterly non-compliance trends for the purchasing card activities.



- 2. **Un-authorized issue of cards** The City's purchasing policy lists the officials that are authorized to use the purchasing cards. We noted ten purchasing cards in circulation during our engagement and only two card numbers 0572 and 9251 were authorized to be issued in accordance with the purchasing cards policy. As such the eight (8) additional cards issued were not authorized to be issued and in violation of the City's policy.
- 3. **Supporting documentation and approval** during our engagement we reviewed 978 purchase card transactions and we noted the following violations of the City's policy:
 - a. 54% of the purchase card transactions did not have any supporting documentation to substantiate the purchase see Table 4 below for details
 - b. 63% of the purchase card transactions did not have a clearly stated and identifiable purpose for the City see Table 6 below for details
 - c. 96% of the purchase card transactions did not have an approval of the City Manager see Table 7 below for details

- 4. **Accounting and reporting** during our engagement we reviewed 978 purchase card transactions and we noted the following violations of the City's policy:
 - a. 60% of the purchase card transactions did not have a general ledger account number to allow for accurate posting and reconciliation into the financial system – see Table 9 below for details
 - b. 62% of the purchase card transactions have no evidence of being posted into the general ledger see Table 10 below for details
 - c. 62% of the purchase card transactions were not reconciled to the general ledger see Table 11 below for details
- 5. **Alcohol purchase** we noted three (3) instances of alcohol purchase from a local restaurant which are in direct violation of the purchasing card policy. We also noted three (3) additional instances where the purchasing cards were used to purchase items from a local "food and spirit" establishment. However we could not determine the exact nature of the three (3) additional purchases because the detail receipts of these purchases were not available. All alcohol related purchases were made on card numbers 0572, 9251 and 8548.
 - We also note that because 54% of all 978 transactions reviewed were missing receipt or supporting documentation and majority of meals and entertainment receipts available were summary in nature, that is receipts only showing the total amount of purchase plus tips, there could have been more purchases of alcohol that were not evident in our engagement.
- 6. Gasoline purchase we noted 17 instances where the purchasing cards were used for gasoline purchase. The City has a dedicated gasoline card that should have been used for these purchases as such these gasoline related transactions could be deemed as unauthorized purchases. All gasoline related purchases were made on card numbers 0572, 9251 and 8548. See Table 13 below for details.
- 7. Personal expenses we noted that because 54% of all 978 transactions reviewed were missing receipts or supporting documentation and 51% of the receipts and supporting documentation available were missing a clearly stated and identifiable purpose for the City we were unable to determine any use of the purchase cards for personal expenses. However, we also note that there are purchase card transactions from retailers that do not appear to sell merchandize to local governments. The details of the transactions on the purchase cards are outlined in the supplemental section of this report.
- 8. Procurement card administration The City's purchasing policy designated the City Manager as administrator for the purchasing cards as such is charged with several tasks such as maintaining cardholders agreement on file, providing instruction and training to card holders, conducting monthly or quarterly reviews of all purchasing card transactions. During our review there were no cardholder's agreement on-file, no evidence of instruction and training were provided to card holders and no evidence of monthly or quarterly review of purchase card transactions.
- 9. **Systemic breakdown in internal controls** we noted systemic breakdown in internal controls surrounding the City's procurement card policy that was in-place during the engagement period. To understand how and why there were significant non-compliance and systemic breakdown it is helpful to know what the internal control components are and how they relate to the procurement card system as a whole since policies and procedures is only one component among several that comprise an effective internal control system.
 - In 1992, the Committee of Sponsoring Organizations (COSO) developed a conceptual framework defining the components necessary to create an effective system of internal controls. That model is now widely recognized as the definitive standard against which

organizations measure the effectiveness of their internal control systems. COSO recently expanded its conceptual framework by drilling down into the components to further define their guiding principles, but the five core components remain the same, as follows:

- A. Control Environment Sometimes referred to as "the tone at the top,"

 Control Environment refers to the example set by executive management in its attitude toward the organization's internal controls. In short, control environment refers to the extent to which management "walks the walk" in its approach to internal controls.
- B. Risk Assessment What can possibly go wrong?
 Risk Assessment seeks to identify risk factors, both external and internal, that could prevent the organization from achieving its objectives.
- C. Control Activities How do we prevent it from going wrong?

 Control Activities refers to the policies and procedures put in place to meet the organization's objectives, while minimizing the risk factors identified in the risk assessment.
- D. Information and Communication Facilitating flow of information
 The internal control system cannot exist in a vacuum. Information and Communication
 refers to the need to foster the flow of relevant information both to and from management
 regarding the effectiveness of the internal control system at meeting the organization's
 objectives.
- E. Monitoring Looks Good on Paper Management needs to continually evaluate the performance of its system of internal controls to identify and correct any flaws in the system.

Detailed engagement results

Our detailed results and recommendations are outlined on pages 6 and 14 respectively.

- Obtained and reviewed the purchasing policy manual executed on April 16, 2018
- Obtained and reviewed the purchasing card policy manual executed on April 16, 2018
- Obtained and reviewed the relevant section of City charter document
- Obtained and reviewed the special called meeting packet outlining the observations and recommendations provided by the 2019 financial statement auditor
- Watched several videos of Mayor and Members of the City Council meetings
- Interviewed Mayor, Members of the City Council and key personnel of the City
- Obtained and reviewed all procurement cards issued to the City's elected officials and personnel from the period of January 2017 to November 2020
- Obtained and tested 100% of the procurement card transactions totaling 978 transactions and \$200,531
- Performed detail testing of each procurement card transaction to ensure that:
 - Transaction has a copy of the receipt / supporting document
 - Transaction does not exceed \$1,000 daily limit
 - Transaction does not exceed \$5,000 monthly limit
 - Transaction receipt / supporting document includes a clearly stated and identifiable purpose for the purchase
 - Transaction does not appear to be for personal use in nature
 - o Transaction was not used for cash refunds or advances
 - o Transaction does not appear to be used for alcohol or liquor
 - Transaction was approved by the City Manager
 - General ledger account for posting is clearly stated and identifiable
 - Transaction has been posted into the general ledger
 - Transaction has been properly reconciled to the general ledger
- Inquired of personnel to ensure all procurement card holders have signed agreement onfile
- Performed procedures to ensure all procurement card population is complete

Recommendations

A positive control environment is the foundation for all other standards as a climate and culture of discipline and structure influences the quality of internal control. This involves properly supporting the purchasing program with adequate resources for oversight and training, as well as making clear what behaviors are and are not acceptable.

We recommend that the City implement the following changes to its procurement card policies and procedures:

General

- 1. A restriction on the use of the card for food and entertainment purchases or align its policies with the State of Georgia statewide purchasing policy dated April 2017. This statewide policy sets parameters on food and entertainment.
 - a. We note that the City's updated policy dated February 7, 2021 has placed a restriction on the use of the procurement cards for food and entertainment.
- 2. A specific date when the monthly or quarterly review of the procurements cards should occur and when any unresolved violations should be reported to the governing authority. The policy in-place during the engagement period did not include a date when these activities should occur.
 - a. We note that the City's updated policy dated February 7, 2021 includes specific dates when these activities should occur.
- 3. All transactions should be accompanied by the following items:
 - a. A completed and approved purchase order or requisition form
 - b. A copy of the transaction receipt or supporting documents that justifies the purpose of the purchase
 - c. A completed and signed expense report, if applicable
- 4. A language that makes it clear that disciplinary action for violation of the procurement card policy includes termination of employment and criminal prosecution to the fullest extent of the law should be included in the procurement card policy.
- 5. A standardized purchase order or requisition form should be placed on the City's website for easy access to all cardholders.
- 6. A standardized expense report form should be placed on the City's website for easy access to all cardholders and personnel.
- 7. Ensure separation of duties and appropriate responsibility such as:
 - a. Establishing an effective approval process through which cardholder applicants are reviewed and approved prior to issuance.
 - b. This process should promote and maintain adequate oversight as the City's needs grow and evolve.
 - c. Approving officials should be selected to ensure sufficient independence and rank to adequately assess purchases.
 - d. The responsibilities of cardholders, reviewing officials, and agency program coordinators should not overlap.

- e. All individuals involved in the procurement card process should be held accountable for timely and adequate participation in the program.
- 8. A prohibition on assigning cards to individuals responsible for administering the program.
 - a. We note that the City's updated policy dated February 7, 2021 designates the Purchasing Agent as the program administrator and also list the Purchasing Agent as an authorized card holder.
- 9. Develop a multi-faceted approach to monitoring and oversight
 - a. The City should have several levels of review and oversight in place including primary, supervisory review and City-wide reporting.
 - b. These levels help identify questionable transactions, split purchases, improper cardholder limits, and fraudulent activity.
 - c. Proper oversight should also include periodic audits for card activity and retention of purchase documentation and a regular review of spending per vendor and merchant category codes.
 - d. The City should be aware and take advantage of automatic procurement card controls provided by the program's service provider.
 - e. These controls may include automatic purchase denial based on merchant category codes and credit limit, as well as other reporting tools.
- 10. The City's stance on loyalty points should be documented and communicated in context with or in reference to the Conflict of Interest policy.
- 11. Software purchases
 - a. The Information Technology Manager should prepare and maintain a listing of all monthly recurring software charges to include the specific user and purpose
 - b. The listing should be updated for software additions and deletions as needed
 - c. The listing along with any additions and deletions accompanied by a purchase order or requisition form should be approved by the City Manager
 - d. The approved listing along with the purchase order or requisition form should be provided to the accounting department as documentation of recurring software purchases

Accounting

- 12. Each procurement card should be reconciled on a monthly basis to the general ledger
- 13. Payments of the procurement card should be approved by the City Manager
- 14. Segregation of duties should be implemented for the monthly accounting of the procurement cards. Appropriate segregation of duties should include:
 - a. Ensuring the individual that reconciles the monthly statement to the general ledger is different from the individual that authorizes the use and payments of the procurement card.
 - b. Ensuring that the individual in the payroll department handling all reimbursement for transaction lacking appropriate supporting documents is different from anyone involved in the transaction cycle.
- 15. Appropriate staffing within the accounting department to ensure that there is adequate personnel to account, reconcile and perform the monthly required functions required by the purchasing policy.

Safety and security

- 16. All procurement cards should be kept in a locked safe in the City Hall at all times.
- 17. A log should be maintained to track the release and return of each procurement card. The log should include the name, date, time, purpose and any other pertinent information to track each procurement card.
- 18. Upon the termination of a cardholder's employment with the City, the cardholder's procurement card should be immediately canceled and no further transactions should be incurred on the card.
- 19. Upon the City being notified of impending departure from the City, the respective cardholder card limit should be reduced to zero.
- 20. Establish a policy to deactivate procurement cards when employees are on leaves.
- 21. Signed Card Holder agreement should be kept on file with the City and the agreement should be updated for changes in the City procurement policies.
- 22. Establish spending limit commensurate with needs
 - a. Cardholder spending limits should align with actual need on a single transaction and total monthly basis.
 - b. Changes in spending limit should be requested in writing through a formalized procedure, and an annual review of the program should include an assessment of credit limit appropriateness.
 - c. Allowing many cardholders to have the same spending limits and limits higher than necessary exposes the City to higher monetary risk.

Training

- 23. Currently, there is no training process for procurement card holders and there is no training manual. As such:
 - a. Training for new cardholders should be provided along with a comprehensive training manual.
 - b. There should be an acknowledgement by new cardholders in regards to reading and understanding the procurement card policy and the training manual.
 - c. Training should be clear on the required procedures along with required supporting documentation to ensure a successfully procurement card program.
 - d. Training should demonstrate to new card holders what constitutes a proper and improper card use and the potential consequences for misuse.
 - e. Periodic training refresh should be required of all current card holders to highlight the importance of adherence to the procurement card policies and consequences for misuse.
 - f. Training should be required for all individuals involved in the procurement card process such as approval, review and reconciliation.
 - g. Training should remind card holders of their responsibility to avoid sales tax payments and the process to recoup the sales tax that has yet to be recouped.

PURPOSE: The Planning and Zoning Department is seeking guidance from the Council on resuming the issuance of special event permit requests from the public.

FACTS AND ISSUES: The Planning & Zoning Department has not been issuing any special event permits during the pandemic. It has been our policy that until the CDC or the County Health Department allows mass gatherings to take place, we will not do so. In addition, the 30058 zip code which encompasses Stonecrest has recently experienced the highest infection rate in the County based on DeKalb Emergency Management data. However, with the increase in vaccination rates, the CDC has started to loosen their restrictions particularly with regard to mask wearing and outdoor gatherings. Other jurisdictions are starting to lift similar restrictions around the State. In reaction, the Department has seen an increase in inquiries regarding holding special events in the City. Now that the Parks and Recreation Department is considering a phased reopening plan, and assuming we do not witness a resurge in COVID-19 cases in the 30058 zip code, we are recommending a coordinated and consistent plan for administering these special event requests moving forward.

Keeping the same phased timeline as that presented by Parks & Recreation, Planning & Zoning offers the following recommendations for your consideration:

> Phase 1

- Accept outdoor special events applications for small gatherings, 50 people or less.
- A COVID-19 action plan must be submitted along with the application.
- Recommended date: Memorial Day Weekend

> Phase 2

- Public outdoor events (150 or less) and Indoor public events (50 or less.)
- A COVID-19 action plan must be submitted along with the application.
- Recommended date: 4th of July Weekend

> Phase 3

- Public outdoor events (300 or less) and Indoor public events (100 or less.)
- A COVID-19 action plan must be submitted along with the application.
- Recommended date: Labor Day Weekend

Again, we recommend that this policy be revisited and the case rate of COVID-19 infections in the 30058 zip code be monitored before each phase is implemented.

PURPOSE: The purpose of this item is for the Council to discuss the City's participation in community improvement districts.

HISTORY: The East Metro Community Improvement District (EMCID) was formed in 2014 by a group of local community leaders with the goal of enhancing the East DeKalb area. A portion of Stonecrest is located within the EMCID boundary.

FACTS AND ISSUES: A CID is a self-taxing district that serves as an economic development tool to implement major improvements. These improvements can include infrastructure, public safety, and beautification enhancements, amongst others. CID's are intended to increase property values, revive local businesses and enhance the overall quality-of-life within their boundaries. With a portion of Stonecrest being located within the EMCID, the City faces a number of possibilities regarding how the remainder of the community's improvement needs can be met and how this can be done in concert with the existing CID.
