Request for Proposal for

City Hall Usage Review and Assessment Study

1.0 Background

- 1.1 The City of Stonecrest, Georgia is a municipality located within the Atlanta-metro region with a population of approximately 50,000 people. The City was formed in 2017 and currently functions under a Council/Manager form of government. The City is approximately 38 sq miles in size and has a mix of residential, business and rural uses that make up the City's landscape.
 - 1.1.1 The City currently operates through a private services contract with Jacobs Engineering to perform the majority of municipal services for the community. These services include Code Enforcement, Building Inspections, Information Technology/GIS, Parks and Recreation, Communications, Engineering, Finance, Planning and Zoning, Economic Development and Administration. The City is currently served by approximately 40 employees who are primarily housed at the Stonecrest City Hall and the City's Recreation Facility.
 - 1.1.2 At the end of 2021, Jacobs will no longer provide municipal services on behalf of Stonecrest. At that time, the City will address their service needs through a combination of hired, in-house personnel and contracted service providers. The City expects their staffing to increase to approximately 50 FTE's at the end of 2021 with the majority of those employees being housed in City Hall.
 - 1.1.3 The current Stonecrest City Hall is located in a portion of an existing building at 3120 Stonecrest Blvd. The building is 2 stories with total area of 56,656 sf. Of this, the City leases approximately 12,500 sf which is comprised of offices, cubicles, conference rooms, Council Chambers, and storage areas. City Hall houses approximately 35 of the 40 staff members working for the City and has currently reached its capacity limit.
 - 1.1.4 The City had previously purchased a local Sam's Club facility to potentially serve as the City's future City Hall facility. Sam's Club is located 2994 Turner Hill Road in Stonecrest. The building is approximately 133,840 sf in total floor area. It was envisioned to potentially include a theater as well as the staffing for various municipal service functions. Since its original purchase, City leaders have begun to question whether there is a better, more appropriate use for the Sam's Club building. This has led to the City's interest in having an evaluation performed on the best recommended uses for the building.
 - 1.1.5 The City of Stonecrest wishes to adhere to several important pillars as part of the development of this usage review and assessment:
 - Transparency the City wishes to be open and transparent to the community in the execution of this review. Public sentiments should be included as a component of the study;

- Cost-effective the City wants to pursue the most cost-effective option, both in the short- and long-term. The cost review should consider capital costs, operational costs, debt service and all other elements that will have a financial impact on the City;
- Maximum public accessibility the City wants to ensure that their eventual City
 Hall, whether at Sam's Club or another location, maintains an accessible presence
 to the citizens of the community. It should be convenient for all constituents who
 wish access to City information, documents and staff; and
- Sustainable best practices for sustainability will be evaluated, analyzed and employed where appropriate in all aspects of the City's future City Hall, especially where cost savings can be realized as a result of its inclusion.

A 1.1 Purpose

1.1.6 The City is seeking the services of a qualified consulting firm to perform all work necessary to evaluate the effectiveness of the current Sam's Club facility, parking and overall parcel as a potential City Hall/City Service Center for Stonecrest. This effort will include a space evaluation that will determine potential staffing capacity as well as a determination of how long the space will adequately meet the future space needs of the City. The City's space needs will factor both a singular administrative component (City Hall) as well as a complete City service portfolio, to include a future Public Works Department (City Service Center). The evaluation will also consider other possible complimentary functions that can be accommodated within Sam's Club parcel/facility as part of the City Hall operations. Other options and opportunities for a City Hall facility to be eventually owned by the City will be presented for consideration and comparison to the Sam's Club alternative. Finally, the evaluation will consider possible alternative uses for the Sam's Club parcel that could be realized if the City were to sell or lease the parcel. Elements of the evaluation include construction costs, revenue projections, maximum staffing capacity, allowable (preferred) alternative uses and other associated data that will allow for a final recommendation to be included regarding best final use for Sam's Club.

2.0 Objectives

- 2.1.1 The usage review and assessment is intended to achieve the following strategic objectives:
 - Ensure the efficient, sound and cost-effective provision of public services to current and future residents, workers, business owners and visitors of Stonecrest;
 - Certainty, accuracy and reliability of data and information that can be relied upon in the development of a final recommendation; and
- Profit-centric model that will ensure maximum return on the City's investment in their future City Hall and the Sam's Club parcel/facility.

Scope Details

- 2.1.2 This scope involves the identification and analysis of the Sam's Club facility as a potential City Hall/City Service Center as well as other possible private/public/combined uses that may be worth considering. Specific tasks shall include:
 - Utilizing all reasonable means to review and assess the Sam's Club building to determine its appropriateness as a future City Hall/City Service Center for Stonecrest.

- Review of existing parking and infrastructure serving the site to ensure its ability to
 provide adequate service for the desired end use(s) of the parcel and associated
 facility.
- Projected future staffing levels for the City, both with and without the inclusion of a
 future Public Works Department. Projections will be based on expected population
 growth, desired City service levels and best management practices for highperforming City operations.
- Identification of other complimentary occupants within the facility and/or parcel in concert with the City Hall/City Service Center use. Complementary uses may include public, private, non-profit or any combination. Examples include private businesses that serve the building occupants, government services provided by other agencies, or any other use that fits within the context of the parcel and surrounding properties.
- Provide local examples of City Hall/City Service Center alternatives that include
 eventual ownership by the City as comparisons to the Sam's Club site. Purchasing
 the current leased City Hall space is one obvious alternative to be evaluate but
 other applicable facilities will also be included. For comparison purposes, the
 alternatives will be evaluated for cost per sf to own/operate/maintain, useful life for
 projected staff growth, feasibility, ease of use, and other applicable details that
 would factor into the decision-making process.
- Alternative uses for the site that do not include City occupancy shall also be provided for consideration. These uses will factor both leases with continued City ownership as well as sale of the property. The City will want to maintain some level of control of the proposed use to ensure it fits within the community vision for this parcel. Therefore, an outright sale without conditions will not be viable option. There is hope that the Sam's Club parcel can be the catalyst for the creation of a Stonecrest "City Center" and therefore, uses that fit within this scheme are encouraged. Examples of desirable uses include a convention center, mixed use retail corridor with a residential component, entertainment complex and multigovernment compound, to name just a few.

Coordination

- 2.1.3 The selected Consultant will need to coordinate their efforts with the City and associated stakeholders. These affected parties include, but are not limited to:
 - City management and directors who would potentially occupy a City Hall/City Service Center facility;
 - Elected officials, when coordinated with and through the Acting City Manager;
 - DeKalb County officials and staff;
 - Stonecrest Economic Development Director, relative to possible alternative uses of the parcel; and
 - Developers, landowners and business owners, with property and projects in close proximity to the Sam's Club site.

General Work Outline

- 2.1.4 The selected Consultant shall perform the following general tasks as part of the usage review and assessment that is expected as the ultimate outcome:
 - Lead a kick-off meeting on-site in Stonecrest with City staff and their technical advisors as well as selected stakeholders to review proposed methodology, confirm project scope and desired objectives, identify all involved parties requiring

- coordination, agree on priorities, establish a communication plan, provide available, applicable data files, documents and plans and confirm the project schedule, including milestones, meetings and dates of deliverables.
- Perform any in-person site/facility review that is necessary to determine the condition of the facility, assets, and infrastructure associated with the Sam's Club site.
- Develop a complete stakeholder list, based on input from the City as well as
 independent research and conduct stakeholder meetings/workshops as deemed
 necessary to gain feedback on potential uses for the property, issues impacting its
 feasibility, interested third parties that may have interest in the property, and
 land/building owners who can offer alternative City Hall/City Service Center options.
 Phone/email/video calls may be substituted for onsite meetings if deemed by the
 City to be appropriate for particular stakeholder(s).
- Perform all necessary analysis, review, research, data gathering and preliminary planning/cost estimating necessary to make sound, defensible recommendations on best possible use of the Sam's Club parcel and facility as well as a future City Hall/City Service Center location.
- Note any necessary repairs, upgrades or replacements to make existing facility, parking, infrastructure and utilities functional to serve the future needs of the City. Include planning-level cost estimates for any identified work required to bring the property and building up to a usable standard.
- Identify ideal potential uses for the Sam's Club site, including those that can
 cohabitate with a City Hall/City Service Center as well as those that can take over
 the site independently. Include information on whether these uses are best suited
 for a lease arrangement with the City or outright sale of the property.

General Requirements / Criteria

- 2.1.5 All recommendations are to be developed with consideration for current and future City services to meet the long-term needs of the community.
- 2.1.6 All potential facility/parcel uses that that are applicable to the Sam's Club site will be reviewed impartially and objectively to ensure that sound, cost-effective solutions are offered for the City's consideration.
- 2.1.7 All recommendations will factor the following criteria as part of the evaluation:
 - Complete Remodel/Repair Costs
 - Operation and Maintenance maintainability, ease and cost
 - Long-term Cost/Efficiency Savings
 - Value Added customer experience and operational improvements
 - Supply and Demand conditions for any proposed non-government uses
 - Applicability to Site site-specific details and adjacent property uses
 - Stakeholder Needs and Preferences
 - Additional Applicable Factors

Duration

2.1.8 Upon issuance of a Notice to Proceed, the Services shall be completed within 180 days including the submission of the Final Usage Review and Assessment Study. The duration and proposed schedule shall be confirmed by all submitting firms


as part of their Technical Proposal submission.

3.0 Deliverables

- 3.1.1 The following deliverables shall be provided at agreed upon deadlines throughout the life of the Usage Review and Assessment Study. Documents shall be provided in both hard-copy and electronic form.
- a) Meeting minutes for all project-related meetings with the City and/or stakeholders. This will include meetings held remotely as well as those conducted in-person and on-site.
- b) Project Update Summary to be provided on a schedule as agreed upon between Consultant and City (ideally every 2 4 weeks). The summary will be a high-level update on the status of the Project including work accomplished, challenges encountered, solutions reached and upcoming work.
- c) Initial Draft Usage Review and Assessment Study for review and comment by the City. The Study will include:
- d) Final Draft Usage Review and Assessment Study for confirmation by City. Prior City comments shall be incorporated into the document unless agreement on alternative course of action is reached.
- e) Final Usage Review and Assessment Study.

Site

3.1.2 The Sam's Club site is bordered by Turner Hill Road. Mall Parkway and Stonecrest Parkway E. It is located east of the Mall at Stonecrest



4.0 PROPOSAL SUBMISSION REQUIREMENTS

- 4.1 To be entitled to consideration, bids must be submitted electronically at https://www.biddirect.com/georgia/cityofstonecrest
- 4.2 The Offeror must submit the following information, preferably in the following order.

Section 1 - Qualifications and Experience

- 1. Description of your firm and its experience with the evaluation, prioritization, and tracking of grant funds, capital improvement plans, or similar exercises;
- 2. The offeror is required to state its organizational resources, which the offeror considers to be advantageous to the successful completion of the project. Items to be considered include the capabilities and experience of the offeror, identification of the principal participants including resumes, certifications and licenses, and office locations.
- 3. Resumes/experience of the project team and identification of the project manager/single point of contact;

Section 2 - Methodology

- 1. Provide a detailed approach to the scope of work, including your initial engagement strategy. Any deviations from or additions to the Scope of Work should be explained;
- 2. Provide your understanding of the project and the City's needs;
- 3. Explain the firm's work plan with detailed specific tasks as noted in the Scope of the Proposed Project section of this RFP. Proposal must consist of all tasks and the responsible parties including the City and sub-consultants.
- 4. Up to 3 profiles of similar projects;

Section 3 – Cost

1. Provide the monthly cost for project management, financial advisory, communications, audit, cost tracking, accounting, and report services on requested on the Cost Proposal Form for year 1 and year 2.

Cost Descriptions Detail

 Project Management Services – project oversite, compliance with project requirements and compliance with federal, state, and local guidelines, regulations policies and related to administrative expenses, accountability, and transparency. Review and understanding of Treasury's final rules, once released.

- Communications Weekly or bi-weekly conference calls throughout the project; create presentations and communications. Provide monthly status update.
- Cost Tracking Accounting and Reporting Services.

7.0 EVALUATION OF PROPOSALS

- 7.1 To be eligible for consideration, proposals shall be presented in accordance with the instructions of this solicitation and within the timeframe specified. It shall be the responsibility of the awarded banking institution to meet all specifications and guidelines set forth herein.
- 7.2 The City evaluation committee will evaluate each proposal properly submitted. The City, at its sole discretion, determines the criteria and process whereby proposals are evaluated and awarded. No damages shall be recoverable by any challenger as a result of the determinations or decision by the City.

8.0 EVALUATION

- 8.1 Evaluations will be based on criteria outlined herein. All proposals will be evaluated using the same criteria. The criteria used will be:
 - Understanding Scope of Work and City needs 250 points

- Project Approach 250 points
- Team/Project Manager Capabilities 200 points
- Team Experience 150 points
- Fee 150 points
- 1) The evaluation will consider all materials submitted to determine whether the vendor's offering is in compliance with the RFP requirements.
- 2) The ability and capacity of the proposer and the skills, experience, and availability of the specific individuals to be assigned to the City to perform the services required.
- 3) The quality of performances by the proposer of previous and similar contracts and such other information as may be secured and considered relevant by the City;
- 4) The ability of the proposer to present professional and innovative work to similar organizations; the skill of the proposer as demonstrated by sample of similar work and reference by similar organizations;
- 5) The proposed fees and charges will be considered.
- 6) Relevance and quality of references.
- 7) City staff may conduct in-person interviews and site visits as part of the final selection process. Additional information may be requested from the financial institution prior to scheduling an interview.
- 8) The City reserves the right to negotiate price and/or non-price terms and conditions with selected banking institution.
- 9) The City reserves the right to negotiate price and/or scope of work terms and conditions with selected financial institution.
- 10) The City reserves the right to negotiate terms and conditions, which may be necessary or appropriate to meet the needs of the City.

9.0 AWARD

- 9.1 The following bid shall be awarded to one "responsive" offeror on a total lump sum price basis. Unit prices and extensions will be verified and total checked. Unit price extension and net total must be shown.
- 9.2 The City, at its discretion, may award the Contract to the responsible and responsive consultant submitting the proposal which is deemed to be the most advantageous to the city. The following is the evaluation criteria the city will consider in determining which proposal is most advantageous to the city.

10.0 CONTRACT PERIOD

10.1 This contract shall be from execution to the end of the usage review and assessment study and to renew at the sole discretion of the City of Stonecrest. This contract will be conditional upon the offeror's ability to comply with requirements set forth in the solicitation documents.

11.0 NON-DISCRIMINATION

11.1 The City does not discriminate on the basis of race, age, sex, national origin, religion, or disabilities and is an equal opportunity employer. Minority and women-owned businesses are encouraged to apply.

12.0 <u>BUSINESS ENTERPRISES</u>

The City strongly encourages Small Business firms to participate in this RFP.

13.0 PERMITS, TAXES, LICENSES, BONDS, ORDINANCES, AND AGREEMENTS

All Corporations should provide corporate seal, a copy of the Secretary of State's Certificate of Incorporation, and a listing of the principals of the corporation with the proposal.

14.0 <u>INSURANCE</u>

- 14.1 Within 10 days of execution of this Agreement, and at all times that this Contract is in force, the Contractor shall obtain, maintain, and furnish the City Certificates of Insurance from licensed companies doing business in the State of Georgia with an A.M. Best Rating A-6 or higher and acceptable to the City covering:
 - a. Statutory Workers' Compensation Insurance
 - a. Employers Liability:

Bodily Injury by Accident - \$1,000,000 each accident

Bodily Injury by Disease - \$1.000,000 policy limit

- b. Comprehensive General Liability Insurance
 - a. \$1,000,000 limit of liability per occurrence for bodily injury and property damage Owner's and Contractor's Protective
 - b. Blanket Contractual Liability
 - c. Blanket "X", "C", and "U"
 - d. Products/Completed Operations Insurance
 - e. Broad Form Property Damage
 - f. Personal Injury Coverage
- c. Automobile Liability
 - a. \$500,000 limit of liability
 - b. Comprehensive form covering all owned, non-owned and hired vehicles
- d. Umbrella Liability Insurance
 - a. \$1,000,000 limit of liability

- b. Coverage at least as broad as primary coverage as outlined under Items 1, 2 and 3 above
- e. The City of Stonecrest, Georgia, and its subcontractors and affiliated companies, their officers, directors, employees shall be named on the Certificates of Insurance as additional insured and endorsed onto the policies for Comprehensive General Liability, Automobile Liability and Umbrella Liability insurance maintained pursuant to this Contract in connection with liability of the City of Stonecrest and their affiliated companies and their officers, directors and employees arising out of Contractor's operations. Copies of the endorsements shall be furnished to the City upon execution of this Agreement. Such insurance is primary insurance and shall contain a Severability of Interest clause as respects each insured. Such policies shall be non-cancelable except on thirty (30) days written notice to the City. Any separate insurance maintained in force by the additional insured named above shall not contribute to the insurance extended by Contractor's insurer(s) under this additional insured provision.

15.0 GENERAL TERMS AMD CONDITIONS

- a. If there is any question whatsoever regarding any portion of the instructions or specifications, it shall be the bidding company's responsibility to seek clarification immediately from the City of Stonecrest Purchasing Department during the question period herein. It shall be the bidder's responsibility https://www.biddirect.com/georgia/cityofstonecrest any/all for addendum(s). Answer(s) to all questions will be given after the deadline for questions has expired and posted to the City of Stonecrest Bidnet portal.
- b. The apparent silence of the specifications and any supplement specifications as to any details or the omission from it of a detailed description concerning any point shall be regarded as meaning that only the best commercial practices are to prevail and that only materials of first quality and correct type, size and design are to be used. All workmanship is to be of the best quality. All interpretations of specifications shall be made upon the basis of this statement.
- c. No reimbursement will be made by the City for any costs incurred prior to a formal notice to proceed should an award of contract result from this solicitation. The proposal must be signed by an official authorized to bind the offeror.
- d. The City of Stonecrest desires delivery of the material or services specified at the earliest possible time after the date of award. An unreasonable delivery proposal may be cause for disqualification of a bid. Each bidder shall state a definite time and avoid using the terms ASAP or approximately so many days.
- e. The City reserves the right to accept or reject any and all responses and to waive technicalities as deemed to be in the best interest of the City. The City reserves the right to request additional information from a respondent(s) as deemed necessary to analyze responses.
- f. Any variation from the specifications must be clearly stated by the bidding company in

writing and submitted with the proposal.

- g. The City does not discriminate on the basis of race, age, sex, national origin, religion, or disabilities and is an equal opportunity employer. Minority and women-owned businesses are encouraged to apply.
- h. The City strongly encourages Small Business firms to participate in this RFP.
- Permits, Taxes, Licenses, Bonds, Ordinances, and Agreements:
 All Corporations should provide corporate seal, a copy of the Secretary of State's Certificate of Incorporation, and a listing of the principals of the corporation with the proposal.
- j. All materials submitted in response to this RFP become the property of the City and will be returned only at the option of the City. The City reserves the right to use any or all ideas presented in any response to the RFP, and selection or rejection of the proposal does not affect this right.
- k. After the initial review of proposals, the City may invite representatives of firms responding to this RFP to discuss the proposal with key personnel who would be engaged in the provision of services. Such interviews will be conducted for fact finding and explanation purposes and will not include negotiation. The City will not be liable for expenses incurred for any such interview.
- 1. Until the City acts formally to approve a contract, and until such contract is signed by both parties, the City is not legally obligated in any respect.
- m. The successful responder must maintain all licenses, permits, certifications, and other authorizations necessary to provide the needed services as required by federal, state, or local laws.
- n. The successful responder will be required to indemnify, defend, and hold the City, its officers, and employees harmless from and against all losses, claims, suits, or judgments, including payment of attorneys' fees and costs, incurred, or asserted against the City as a result of or arising from the firm's negligent acts or omissions. This provision of a contract resulting from this RFP will survive the expiration or termination of the contract.
- o. During the Selection Process, the City reserves the right for any reason deemed appropriate by the City: to waive portions of the RFP; to waive any minor informality in the proposal; to request "best and final" offers; to reject any and all Proposals; to terminate the RFP; and to issue a new RFP.
- p. Termination of Contract: It is understood that the City retains the option to terminate this Agreement for any reason at the end of each contract year without pecuniary risk or penalty or at any point during the contract term with evidence of just cause. The termination will become effective, and this Agreement shall terminate sixty (30) days prior to the end of the contract year or for just cause. The termination will become

- effective, and this Agreement shall terminate thirty (30) days following written notification of intent.
- q. Force Majeure The City shall not be responsible for any delay or failure of any other obligations hereunder due to any occurrences commonly known as force majeure, including but not limited to, acts of God, war, acts of terror, labor disputes, strikes, lockouts, civil commotion, pandemic, epidemic, international trade disputes, or acts of government or government agency or officers.

16.0 PROFESSIONAL SERVICES AGREEMENT

16.1 The selected Contractor is expected to enter into the standard City agreement as per Exhibit C. Responding organizations are able to propose their own agreement. The City reserves the right to reject any proposed agreement that does not conform to the specifications contained in this RFP and which is not approved by the City Attorney's office.

17.0 CAUSES FOR TERMINATION

17.1 Causes for termination of the agreement may include an of the following: Failure to promptly and faithfully provide the services required at the prices indicated in the proposal; violation of any law governing services provided to the City; failure to cooperate upon receiving any reasonable request for information or service; or improper actions of the officers or employees which, in the opinion of the City, would adversely affect its interest, or endanger the structure of the City such as a spin off or merger which materially affects the terms of this agreement. The City may terminate the agreement without penalty on 90 days' notice.

18.0 AWARD OF CONTRACT

- 18.1 The Purchasing Department will open the Proposals and prepare a register of those responders submitting proposals. All proposals shall remain firm for forty-five (45) calendar days after the Proposal opening.
- 18.2 Before awarding the RFP, the City may request additional information from Responders.
- 18.3 The City reserves the right to reject any and all Proposals if it determines that the criteria set forth has not been met or for any other reason in its sole discretion.
- 18.4 The RFP contract will not necessarily be awarded to the Responder submitting the Proposal that receives the highest rankings or submits the highest financial proposal. The City will award the contract to only one responsive and responsible Responder submitting the most advantageous proposal taking into consideration the evaluation criteria, responsiveness of the proposal to the RFP Requirements, program goals and objectives, benefits to the community, and overall costs to the City.

The selected proposal will be presented to the City of Stonecrest Mayor and City Council for formal acceptance and authorization of an Agreement.

19.0 PROPOSALS REJECTIONS

- 19.1 The City reserves the right to accept or reject any and all responses and to waive technicalities as deemed to be in the best interest of the City.
- 19.2 Proposals will be rejected from any party (as an individual or as part of a partnership or entity) who:
 - Is delinquent in the payment of property or other taxes with Stonecrest;
 - Is delinquent in the payment of a loan(s) with the City;

CONTRACT AGREEMENT

AGREEMENT BETWEEN THE CITY OF STONECREST AND ______ FOR REQUEST FOR PROPOSAL FOR STONECREST CITY HALL ANALYSIS

WITNESSETH:

WHEREAS, Company is engaged in the business of providing the necessary materials and labor to complete the Work in the manner therein specified within the time specified, as therein set forth; and

WHEREAS, the City of Stonecrest seeking proposals for qualified vendors to provide an analysis of potential city hall locations.

WHEREAS, Company is willing and able to render said services;

NOW, THEREFORE, in consideration of the mutual terms, conditions and covenants set forth herein, the parties hereto agree as follows:

1. SERVICES

Company agrees to render services (the "Services") to the City to furnish all specified materials or approved equivalent, equipment, and labor to complete the required renderings and assessments as described in its entirety to the specifications as directed and the terms of this contract including all incidentals as directed by the City Manager or his representative or as set forth in Exhibit "A" specifically as detailed in the Scope of Services. Company agrees to perform the Services at the direction of the appropriate department head, or his designee, in the manner and to the extent required by the parties herein, as may be amended hereafter in writing by mutual agreement of the parties.

2. COMPENSATION

- a. <u>Fee.</u> In consideration for Services, City shall pay to Company a fee not to exceed the cost described in the Submittal, incorporated herein as Exhibit "B". The full cost of said services shall not exceed \$______ for all the services detailed.
- b. <u>Manner of Payment.</u> The City agrees to pay said invoices within thirty (30) days of receiving same. As the City is a local government entity and thus exempt from sales taxation, notwithstanding the terms of the submittal, Company acknowledges that the City shall not be

responsible for payment of any sales taxes on any invoices submitted for the services provided under this Agreement.

3. RELATIONSHIP OF PARTIES

- a. <u>Independent Contractors</u>. Nothing contained herein shall be deemed to create any relationship other than that of independent contractor between City and Company. This Agreement shall not constitute, create, or otherwise imply an employment, joint venture, partnership, agency or similar arrangement between City and Company. It is expressly agreed that Company is acting as an independent contractor and not as an employee in providing the Services under this Agreement.
- b. <u>Employee Benefits</u>. Company shall not be eligible for any benefit available to employees of the City including, but not limited to, workers' compensation insurance, state disability insurance, unemployment insurance, group health and life insurance, vacation pay, sick pay, severance pay, bonus plans, pension plans, or savings plans.
- c. <u>Payroll Taxes</u>. No income, social security, state disability or other federal or state payroll tax will be deducted from payments made to Company under this Agreement. Company shall be responsible for all FICA, federal and state withholding taxes and workers' compensation coverage for any individuals assigned to perform the Services for the City.

4. CONTRACT PERIOD

The performance period for this contract shall be upon completion of the full scope of work. Contract performance shall begin on the date stated in the contract award letter.

5. TERMINATION FOR CAUSE AND FOR CONVENIENCE

Either party shall have the right to terminate this Agreement if the other party is in default of any obligation hereunder and such default is not cured within ten (10) days of receipt of a notice from the other party specifying such default. "Default" shall mean:

- a. If the City fails to make payments when due or fails to perform or observe any of its duties or obligations under the terms of this Agreement;
- b. If Company fails to perform or observe any of its duties or obligations under the terms of this Agreement;
- c. If either the City or Company shall have made any warranty or representation in connection with this Agreement which is found to have been false at the time such warranty or representation was made and is materially harmful to the other party.

This Agreement may also be terminated by the City for convenience by giving Company written notice sixty (60) days prior to the effective date of termination.

6. COMPENSATIVE IN EVENT OF TERMINATION

If this Agreement is terminated by the City for convenience, Company shall be exclusively limited to receiving only compensation for the pro-rata work performed and appropriately documented to and including the effective date identified in the written termination notice, but in no event shall Company receive less than a prorated amount of the service fees hereunder. Any amount over the amount otherwise due by the City for the services provided prior to the termination date shall be refunded by the Company within ten (10) days of the date of termination, with the exception of any costs incurred by the Company in removal of equipment and shutting down the project, which costs shall be borne by the City in the event of termination for convenience.

7. TERMINATION OF SERVICES AND RETURN OF PROPERTY

Upon the expiration or earlier termination of this Agreement, Company shall immediately terminate the Services hereunder and shall deliver promptly to the City all property relating to the Services that is owned by the City.

8. STANDARD OF PERFORMANCE AND COMPLIANCE WITH APPLICABLE LAWS

Company warrants and represents that it possesses the special skill and professional competence, expertise, and experience to undertake the obligations imposed by this Agreement. Company agrees to perform in a diligent, efficient, competent, and skillful manner commensurate with the highest standards of the profession, and to otherwise perform as is necessary to undertake the Services required by this Agreement, including the requirements set forth in the Certification of Sponsor Drug Free Workplace Exhibit "C".

Company warrants and represents that it will, at all times, observe and comply with all federal, state, local and municipal ordinances, rules, regulations, relating to the provision of the Services to be provided by Company hereunder or which in any manner affect this Agreement.
